

Important Reservation & Tour Information

Tours are operated with a minimum of **25 passengers**. Please book early. Space is limited.

We will use this information only to be passed on to airlines if travelling via air is part of your itinerary; to Canadian and U.S. customs if applicable; and insurance company/companies if you purchase insurance via our office.

If you do not wish Fehr-Way Tours to maintain your information already on file for the purpose of processing travel or receiving travel related information, please contact our office.

DEPARTURE AND ARRIVAL INFORMATION: All Fehr-Way Tours departing via Motor Coach will depart and arrive at the Fehr-Way Tours office at 1050 Henderson Hwy., and the Holiday Inn at 360 Colony Street.

Air packages depart from airports, as specified.

1. RESERVATIONS: Reserve your seat well in advance. A deposit of \$200.00 per person (unless specified otherwise) is required with each reservation within seven days of booking. VISA & MASTERCARD accepted.

Fehr-Way Tours recommends clients purchase comprehensive or cancellation travel insurance at time of booking. This must be purchased at time of initial deposit.

FINAL PAYMENT: Due 45 days prior to departure date (unless specified otherwise). In the event you book your tour within the final payment deadline of the scheduled departure, the total amount is due.

Your **TOUR DOCUMENTS** will be sent two weeks prior to departure.

OUT OF TOWN PASSENGERS: Fehr-Way Tours can arrange overnight accommodations prior to or upon completion of tour. Advise at time of booking should this service be required. Subject to room availability.

Pick-ups may be made along our tour route. Office to be advised at time of booking.

2. TRANSPORTATION: Fehr-Way Tours with its own specialized tour coaches is owned and operated as a family business, out of Manitoba. Coaches are ultra modern, air conditioned, washroom equipped, with reclining seats, air ride suspension, DVD, and tinted scenic windows. All designed for maximum comfort.

3. LUGGAGE: One suitcase per person. Tagged luggage will be stored in the lower compartment of the coach and delivered to your room each night if hotel luggage handling is included in your tour. Fehr-Way Tours cannot assume responsibility for lost or damaged luggage. We recommend luggage insurance. Dimensions for your tagged luggage should not exceed 28" x 20" x 9" per piece. Maximum weight is 50 pounds. Dimensions for carry-on baggage should not exceed 9" x 15 1/2" x 21 1/2".

4. TRAVELLING COURTESIES: Passengers rotate seats twice daily on the motor coach at the direction of the tour director. Exceptions cannot be made. People travelling single or triple must sit with others so as to accommodate couples. In case of two people travelling separately, but sharing a seat, you alternate the window seat.

5. ACCOMMODATION: Hotel and motel selections are selected on their good standard of comfort, service, and location. Triple and Quad accommodation is a room with two beds only. It does not cover the cost of a cot. Available upon request.

6. SMOKING: A No Smoking policy is observed on our motor coaches. Frequent stops are made for your convenience.

7. SINGLE PERSON: Requesting a travelling companion? We cannot guarantee this request can be fulfilled, however, we will endeavor to assist you. Price per person will change when a roommate cancels and your accommodation type changes.

8. TRAVEL DOCUMENTATION: It is your responsibility to determine what documentation is necessary for travel for each country to be visited. In the event you do not obtain the required documentation you will be denied boarding by the air carrier or refused entry into the country or destination. No refunds will be made under such circumstances. **A valid passport is required for all air travel outside Canada. A valid passport is required for ALL travel into the U.S.A. Passengers not of Canadian citizenship should contact the U.S. Immigration Board as a Visa may be required for entry into the United States, and re-entry into Canada.**

9. SCHEDULE CHANGES: Tour management reserves the right to make any adjustments in plans which may be necessitated by local conditions or which may add to the comfort and well-being of the tour.

10. CANCELLATION PENALTIES: These charges are the amounts Fehr-Way Tours will withhold should you need to cancel. The amount of the charge is dependent upon the date notification of cancellation is received by Fehr-Way Tours with respect to the tour departure date.
